Membership looking good; time to review service opportunities

Welcome, Post 12137 and the student veterans in the Eugene, Springfield, area who have committed to a new VFW Post. A special "Thank You" to District 13 Commander Rick Higgins and Past State Commander Tom Laing for their initiative, leadership and hard work in recruiting members and mentoring this new Post.

The winter weather that much of the State has been experiencing has been a drag on our membership goals. As we see the sun shine and even some welcome rain it is time to renew our efforts to retain members and welcome new members to this great organization. January and February saw very little positive movement in membership. Statewide, we need an additional 900 members to equal last year's total membership. The good news is that we have time to make this goal before State Convention. Every Post and District is within striking distance of obtaining 100% membership. There are over 2,500 members on Post unpaid lists throughout the State.

Organized home visitations will ensure that the Department of Oregon will finish the year with at least as many members as we had at the start of the year. Home visitations provide an opportunity to make contact with members who Post leadership normally do not see. It is an opportunity to check on the well being of Post members and simply meet our fellow comrades. It is also a time to update contact information with current email, phone numbers and mailing address. Many members will pay their dues at the home visitation because it is convenient or perhaps because the visit makes them realize that the Post cares about them. The home visitations also give the Post reliable information on members who are in distress or needy and/or disabled. You will also find that some members are on active duty. Members in these situations are candidates for aid and assistance from the Post relief fund.

This proactive approach will pay dividends and insure the strength of the VFW. Doing nothing will result in continued reduction in membership and reduce our influence in the battles that must continually be fought for earned benefits for veterans of all ages.

Remember that effective 1 January 2014 we are on "subscription dues." Members who pay their dues now are paying for the next 12 months. Their dues will become due in 2015 on the anniversary date that their dues payment is processed at National. This also applies to new members recruited after 1 Jan.

The State membership team will be working hard throughout the State, but I also need the help of the 60 Posts and 12 Districts that have not yet obtained 100% membership.

We inherited this great organization from generations of combat veterans before us. I know you feel as I do that we should all strive to leave our Post, District and State in better shape than we found it.

Home Depot Grant

The Home Depot (HD) has just opened their Community Impact Grants cycle which will be in effect until August 15, 2014. There will likely be 2-3 rounds for submission during that time frame.

VFW Posts can receive up to \$5,000 to fix up their Post building. Although there are no guarantees (so please be mindful of that) I encourage all Posts to apply ASAP if you desire to remodel your building.

YOU WILL COMPLETE THIS APPLICATION DIRECTLY VIA THE INTERNET ONLY (no telephone calls to HD, emails or written submissions will be accepted nor will you be able to turn this application in at your local HD store).


ALSO PAY CLOSE ATTENTION TO THE TAX ID INSTRUCTIONS SECTION. You will use the Employee Identification Number (EIN) of your Post and upload the Post's 501(c) (19) IRS determination letter

at the end of the application. If you cannot locate the Post's 501(c) (19) letter let me know as I can give you instructions on how to request a duplicate copy from the IRS.

If you receive funding it will come in the form of Home Depot gift cards that can be used to buy materials at your local HD store. You will need to recruit Post members or other community volunteers to do the work. The project must be completed within 6 months. You will also be required to submit a final report. You should also be willing to include stories and before-and-after photos of the project. Failure to do so will negatively impact your Post's ability to receive any future funding from The Home Depot.

After submission of the application, you should receive an email response usually in six weeks letting you know if you received the grant.


Please do not allow ourselves to become complacent in this fight, millions of Veterans are depending on us.

I hope that this message finds you and your family in good health and content. I hope that you have recovered from the snow storm. Ever think about the emergency vehicles heading all over the place to render aid and what dangers they may encounter?

A law enforcement officer and a soldier must face almost the same dangers. A law enforcement officer is less equipped, has to face a situation by himself and, sometimes his help is at least 20 minutes out. They have to make a "blink-of-an-eye" decision in taking fatal action. Then they have to worry about the outcome of their action in a civil action suit, not to mention administrative review.

If you ask a person about their opinion about law enforcement officers, more likely they will give you a negative response. If you ask why, they tell you about a negative contact they had with them. Was it an unjustified contact? They will tell you it was but the fact is, it was justified; or that they see them doing nothing but eating donuts.

I would like to thank the two posts that took the time and effort to send me their nominations for the Public Servants Award. They were Jasper C. Lent VFW Post 1442 Portland, and Deschutes Post 4108 Redmond.

Jasper C. Lent VFW Post 1442 submitted Representative Greg Matthews from District 50 Gresham for the Veterans of Foreign Wars National Firefighters Public Servant Citation.

Representative Greg Matthews' biography states that he is serving his third term in the Oregon House of Representatives, representing House District 50 which spans most of Gresham. Greg serves as Chair of the Veterans and Emergency Preparedness Committee, and also sits on the Public Safety Committee and the Business and Labor Committee. Greg served in the United States Army as a paratrooper and a military police officer. He served in Operation Urgent Fury in Grenada, West Indies and achieved the rank of Sergeant.

After completing his military service, Greg joined Gresham Police Department. Greg served as a motorcycle traffic officer, SWAT member, and taught Drug Abuse Resistance Education (DARE) at Gresham Barlow School District. His 11 years of service earned him recognition as the "Officer of the Year" by the Fraternal Order of Eagles in 1997.

Greg transitioned from the Police Department to the Fire Department in the fall of 1997. He served as a public information officer, public education officer, and arson investigator. Greg currently serves as a lieutenant for the City of Gresham Fire and Emergency Service Department. In 2005 he was named the "Gresham Fire Employee of the Year", and in 2008 he was named "Gresham Firefighter of the Year."

Every summer, Greg works with at-risk kids at Camp Rosenbaum to show them they can choose to live a better life away from the troubled paths of dropping out of school, crime, gangs, drug and violence. Greg regularly participates in drug-free school events, and can often be found emceeing local charity auctions and community events.

Greg and his wife, Suzette, are small business owners and the parents of three daughters.

A Profound Prayer



Officers Elections 2014 - 2015

By the time you read this some of you will have had your first call for nominations of Officers for the 2014–2015 year. Each year, we have Posts submitting incomplete election reports which are primarily due to wrong addresses and/or phone

number. Please ask your members if the information you have is correct, and on file with the National organization.

The election of Officers takes place at your April meeting, and the Officers are installed at your April or May meeting. They will assume office on June 8, 2014 after the Department Commander has been installed. All Post Quartermasters are to submit the Post-Election Report to the National Organization and Department Headquarters *immediately following* the election —do not wait until the Officers have been installed.

Every Post in the Department of Oregon will elect one (1) delegate and one (1) alternate for every 30 members or fraction thereof, the Post will pay \$6.00 for each delegate plus \$6.00 for the Post Commander who is also a delegate by virtue of his office. The delegate fee must be paid regardless of the number of delegates attending the Department Convention and must be paid and received prior to May 20, 2014.

Every Post will also register at least one delegate to the National Convention, and pay \$25.00 as a registration fee for the 1st Delegate and \$10.00 for each additional delegate attending. The \$25.00 must be paid regardless if anyone from your Post is attending the National Convention or not, as outlined in Section 222 of the National By-Laws and Manual of Procedure; this fee must be paid prior to the convening of the 115th National Convention in St. Louis, MO.

If you plan on attending the 115th National Convention, you can now make your hotel reservations online, by fax or mail using the housing form which is available at vfw.org, or from your Post Quartermaster. If all else fails, call Department Headquarters for the housing form.

GENERAL ORDER #2

March 1, 2014
 2013 - 2014 Series

TO BE READ AT A REGULAR MEETING AND FILED:

1. For the purpose of Clarification, we do not operate as a men's organization or a ladies organization, but as the Veterans of Foreign Wars of the United States and its Ladies Auxiliary.

2. IAW Department of Oregon By-Laws, Article VII, Sec.10; the following members are appointed to the Convention Rules Committee: Chairperson, Linda Kelly; members, Wayne Sharp, Tyler Marriott and Roger Ege.

3. Election of 2014-1015 State Officers will be conducted at the 2014 State Convention. Nominations and elections will be IAW with State and National By-Laws and Convention Rules.

4. All actions taken by the Convention that is, votes by the Convention, other than election of Officers will be presented to the Convention in the form of a resolution or proposed By-Law amendment as specified in Department of Oregon By-Laws, Article VII, Sec.12.

5 Pursuant to Section 222 of the National By-Laws - Delegates and alternates to the Department conventions shall be elected at a regular meeting of the Post held not less than thirty (30) days prior to the Department convention. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at the time of the election

6. Attention of Post Commanders is directed to Section 222 of the National By-Laws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National

Convention Post and Delegate Registration form that will be mailed to all Posts as part of the Election Report/Convention Registration mailing going out this month. Registration forms for the 115th National Convention should be mailed to: Convention Registration, 406 West 34th Street, Kansas City, MO 64111

7. Attention is directed to Section 213 of the National By-Laws concerning any Post in arrears for any financial obligations to District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post-Election Report for the ensuing year, or other obligations, shall be deprived of all representation in District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

8. Pursuant to Section 403 of the National By-Laws and the Manual of Procedure, each District shall hold an annual District convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department convention.

9. Section 222 of the National By-Laws provides that Posts shall elect delegates and alternates to District conventions at a regular meeting of the Post held not less than thirty (30) days prior to the District convention at which District officers are to be elected: one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at the time of the election.

10. Voting for candidates at the District Convention must be in accordance with National By-Laws Sec. 421. If there is more than one candidate for an office voting must be conducted by delegate strength.

11. Members accepting nominations for District Officer are encouraged to review Manual of Procedure Sec 418, Officers: Duties and Obligations, before they are elected. It is essential that District Commanders pay particular attention to duties in MOP Sec 418 and District Commanders duties in the Department of Oregon Procedural Guide, District Commanders. Note that 2013 -2014 and 2014-2015 District Commanders are required to attend the 2014 State Convention. 2014-2015

District Commanders must be at the State Officer installation to be properly installed.

12. District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

13. IAW National By-Laws Sec. 217; first nomination of 2014-2015 Post Officers must be held at the March Post meeting. Nominations will be held open until the April Post meeting and elections will be held at the April Post meeting. Post Officers must be installed prior to the convening of the Department Convention. Post installations are normally conducted at the May Post meeting.

14. Pursuant to Section 216 of the National By-Laws the Post will elect the Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Chaplain and three Trustees. The appointed officers shall consist of at least an Adjutant, Judge Advocate, Surgeon, Officer of the Day, Service Officer and Guard.

15. Post and District election reports must be submitted to National and Department immediately after Post elections in April and District elections at the District Convention. It is important that the reports are legible and the contact information is current and accurate. It should be noted that if the election report is completed on the National web-site, the spelling of the officer's name and contact information will be what is on file at National. If an officer has had a change in his/her contact information and has not updated their file at National, the election report will reflect incorrect information.

16. Members accepting nominations for Post Officer are encouraged to review Manual of Procedure Sec. 218, Officer and Chairman, Duties and Obligations, before they are elected.
