Two National Recruiter Training classes have been arranged for you to attend: (1) Willamette Post 293, 1626 Willamette Street, Eugene, on Saturday, March 28, 2020 from 0930 to 1530: (2) Three Rivers Post 1324, 104 S Tumwater Drive, Oregon City, on Sunday, March 29, 2020 from 0930 to 1530. National has promised to provide us with retention training. Auxiliary members are also welcome to attend. Please call Headquarters to let us know if you are coming. Both Posts' Auxiliaries will be providing a lunch that you pay for at the time of the meeting. I strongly urge all Posts that are not 100% to send one or more representatives for this training. For us to meet our minimum goal of 100% this year, I need you to make an honest effort to knock on doors and call your non-paid members. Members of the State's VFW and other state veterans need us to get this done. (See page 12 for cancellation info).

We are kicking off our next round of "Get on Board There is Room for One More" visitations to Posts: (1) District 12 on March 7; (2) District 15 on March 15 and March 21; (4) District 16 on March 21 and March 22. The judging for the Voice of Democracy competition was done by members of Chemeketa Community Collage faculty and staff. The July 2020, 40th National Veterans Wheelchair Games are being hosted by the VA in Portland, Oregon. Approximately 600 paralyzed Veterans will be competing in this event. The Commander is challenging the Auxiliary and MOC/MOCA



Auxiliaries to join us in supporting this worthy event. Department's recommended minimum involvement is as follows:

- Minimum Sponsorship \$10,000
- Purchase a 10' x 10' discounted non-profit booth for recruiting and VFW information
- Volunteers

We are asking our Districts, Posts and membership to consider donating money for this worthy event. Along with the Department Auxiliary and MOC/MOCA Auxiliaries' participation in donations, we can together reach the minimum \$10,000 sponsorship. We will make sure the donation will be cited on the sponsorship submission paperwork. Our Department will recognize with a poster each District, Post, Auxiliaries and members that donate. This sign will be posted at the 10'X10' booth at this event.

At the "kick-off" Wheelchair Games meeting, the VA did specify a total number of volunteers needed for this event. However, the amount we heard was approximately 2,500. We will be urging our District Commanders to encourage Post members to sign up as volunteers once we get the number needed and specific job descriptions of the volunteer duties. We believe the Auxiliaries will also consider this a worthy event to support and will be volunteering alongside us.

The Commander will set up a 40th National Veterans Wheelchair Games Committee and Chairman, with next year's Commander George Carroll's approval to keep us up to date as the year progresses. If you can give the time and effort needed for us to plan our involvement in this special event, let Department know. We owe big "Thank You" to Harvey Pitcher, VAVS Rep, for notifying Department that we should be involved in this event.

If you haven't paid your obligations for this year, please think about sending in money for that, we have National Home Health & Happiness and the \$1.25/member for Hospital. The money for the hospital is the money that is given by the Department to the hospitals to do their jobs. If we don't have all that money in the account then we can't send all the money to Hospitals.

At the last Council of Administration meeting, we voted to pull \$6,000.00 out of our National Home account to pay for a generator for the Oregon Cottage. The Post was giving money also and they told me what we were sending would be enough to pay for the generator so I would like to get some money to put back into the

Savings account so if you would like to send some money to put back in our Savings account please send the money and note on the check it's for the generator fund.

Membership is coming in very slowly, we need 317 members to be 100% and we have to have that by June 30, 2020. We have 30 auxiliaries that haven't made it to 100% yet this year. That means we have only 17 auxiliaries that are 100%. We have 17 auxiliaries that need less than 5 to be 100%. If you pay the per-cap for the few that you have left you can receive \$50.00 from National.

Its hard to do it on your own but we will help you if you need it. We need to get our numbers up.

Greetings ,VFW Auxiliary Brothers and Sisters. It is 2020 and the beginning of a brand-new Legislative year. The VFW has published their 2020 Priority Goals for Congress, Veterans Affairs, and the Department of Defense to act upon and for us, as VFW Auxiliary members to support.

The 2020 goals include:

- Budget: To fully fund programs for veterans, service members, and their families.
- HEALTH CARE: To ensure service members and veterans receive timely access to high-quality health care without increasing cost shares.
- DISABILITY ASSISTANCE & MEMORIAL AFFAIRS: To ensure veterans and their survivors have timely access to earned benefits.
- EDUCATION, EMPLOYMENT & TRANSITION ASSISTANCE: To ensure veterans succeed after leaving military service.
- MILITARY QUALITY OF LIFE: To maintain a quality, comprehensive benefits and retirement package that is the backbone for an all-volunteer force.
- NATIONAL SECURITY, FOREIGN AFFAIRS & POW/MIA: To fully support service members and their mission to fight the war on terrorism and protect our nation's citizens and interests around the world.

To see the detailed information about the goals, go to the VFWAuxiliary.org. Log in and select "Resources," then scroll down to Legislative. There you will find the "Priority Goals Brochure" that you can print out. There are also other great resources there, such as "Guide to the Legislative Process," Guide to Contacting your Legislators; and "VFW Auxiliary Involvement in Elections and Political Activities."

The 2020 Legislative Conference in Washington DC is scheduled for Sunday, March 1 through Thursday, March 5, 2020. Commander in Chief "Doc" Schmitz will testify before the Veterans Affairs Committee. You can watch the testimony via live stream on the VFW website. Members of the VFW and VFW Auxiliary will also be visiting our Senators and Representatives in their DC offices during this period to directly advocate for our veterans. I will be part of the Department of Oregon delegation and I look forward to being able to advocate for our veterans and their families in person with our Legislators.

"Perma-Press" Wrinkle. He's got the skinny, and the Cooties, really bad!





GENERAL ORDER #2 2019-2020 Series

TO BE READ AT A REGULAR MEETING AND FILED:

1. As of March 11, 2020, 19 cases of the Coronovirus have been identified in the state of Oregon. There are cases in Polk, Marion, Umatilla and Deschutes County, however the chances for infection at a VFW or Auxiliary meeting or function remains very low. We are not anticipating the necessity to cancel events at this time, however, Post and District officers should be aware of events in their communities that indicate a significant change in the situation, such as school closings, at which time canceling events is appropriate. If you do feel that it would be appropriate to cancel events or meetings, please notify Department immediately.

We understand that many of our members may be at higher risk of serious illness because of age and chronic medical conditions such as heart disease, diabetes, and lung disease and that they should take actions to reduce their risk of getting sick. So, we are asking our members to be aware of the symptoms and risks of infection and take precautions against infection. Please read the following information:

2. Know the Symptoms:

COVID-19 causes flu and cold-like symptoms, including fever, cough, and shortness of breath. The symptoms usually appear 2 to 14 days after being exposed to the virus.

3. <u>How it spreads:</u>

The coronavirus spreads through respiratory droplets from coughs or sneezes. These droplets fall to surrounding surfaces, and when touched, end up on your hands. The virus then enters the body when you touch your eyes, nose, or mouth.

4. Take precautions against infection:

- a. Keep your hands clean by washing with soap and water for at least 20 seconds or using a hand sanitizer with at least 60 percent alcohol
- b. Avoid touching your eyes, nose, and mouth
- c. Cover your coughs and sneezes with tissues or your arm/sleeve and dispose of tissues in the trash
- d. Avoid people who are sick
- e. Avoid sharing items like dishes and bedding and keep surfaces clean with disinfecting wipes Get a Flu Shot if you haven't already. While there currently is no vaccine to prevent the coronavirus, you are still advised to get a flu shot. The flu vaccine won't protect you from the coronavirus, but it could prevent you from getting both viruses at once.

GENERAL ORDER #3 2019-2020 Series

March 17, 2020

TO BE READ AT A REGULAR MEETING AND FILED:

1. Temporary Emergency Meeting Measures

I feel it is appropriate to provide the VFW Department of Oregon's Districts and Posts with recommended temporary coronavirus (COVID-19) emergency meeting measures due to our real concerns of providing safe meeting places to conduct business. This emergency meeting measure remains in effect during the COVID-19 health crisis or suspended in the future by the next State Commander. All your State line officers have been consulted in order to enable me to offer you the best advice possible.

- 2. All Districts and Posts must hold elections in April and provide an election report in accordance with Section 217 and 417 of the National Bylaws. If we are all willing to be flexible, there is no reason we can't hold elections in April. At the time of the elections, ask all elected officers to provide their proof of eligibility. If a member to be nominated for an office cannot attend or be a part of the meeting, that member must submit in writing to either the Commander or Adjutant their agreement to be placed on the ballot, prior to the election.
- 3. During this time of nationwide health crisis, we must work "outside the box" and reexamine what constitutes a meeting and the minimum quorum of (5) five members. As the Commander for this great Department, I offer the following advice with the understanding that these recommendations are not required, but will be acceptable to the Department:
 - **a. Meetings do not need to be held at Post.** If the meeting is to be at the Post, consider only having a minimum quorum attend the meeting. The individual names of the members who will make up the quorum must be provided to Post or District members so any member can share their concerns on matters they want brought up, etc. Make sure all members get copies of the meeting minutes.
 - b. It is the individual Post or District that is responsible for conducting meetings, other Post business such as bingo and fund raising. It is recommended that the Posts and Districts follow the guidelines set out for our use in accordance with our governmental leaders and health agencies. In this way, we will not put our members or members of the public in potential harmful situations. Please exercise common sense when making decisions on our activities.

Unfortunately, the **Membership Classes** scheduled for March 28 & 29 has to be canceled due to the coronavirus

- Commander(HOST) Setup account
 - Free to Pricing Plans
 - District 15 used the Pro plan (\$14.99 month) because it had recording and voting(poling) options which are mandatory for meeting requirements.
 - Alternate Option: GoToMeeting (GoToWebinar) was the next best option but price is considerably more at \$249 month for the voting and recording requirements
 - There are many other Web Conferencing Software, but with time invested in research for the needs and requirements for VFW meeting bylaw requirements District 15 found <u>zoom.us</u> was the most professional for the VFW needs and requirements even though there was limited cost involved.
 - 4. Prepare Opening Online Procedures (Online ONLY)
 - prepare normal manual and procedures with Screenshots to share to attendees of these items
 - Pledge
 - 2. Bible Open
 - 3. Charter Draped
 - screen background (optional)
 - Prepare and Share Agenda with addendum of proposed motions and ELECTION Roster to tally (if there is competition)
 - The primary (QM/Bills/Budget) and proposed motions and election tally SHOULD be placed in zoom PRIOR to meeting by host. (the Host is the Commander!)
 - Reason why; It makes it easier to send poll to attendees during meeting.
 - Also recommend adding additional generic motions in system then assign later as motion 1, motion 2, etc...
- Notes of lessons learned;
 - If time and price permits (14.99 Pro plus 40.00 webinar add on will be a total of 54.99) the Webinar option provides registering for meetings and will save time in getting members properly documenting for the record of those in attendance. The webinar option would probably be the best option for larger meetings for taking roll call of officers present. Also webinar attendees can be over 10,000.
 - If others in attendance ie. Department Representative and quorum in person attendance (may be waved for this emergency procedure) utilize only one recording device to eliminate feedback or echo.
- Election requirements will require letters of nomination acceptance for officers up for election before meeting is commenced.
 - 1. Voting determined by delegate strength
 - 2. Installing Officer (video preferred)
 - 3. Installation of Officers (Preferred video)
- Online procedure normally are required to be voted on by the body but may be waved due to emergency procedures
