The VA has added presumptive cancers to Gulf War and Post 9-11 Veterans. To qualify, veteran must has served in a qualifying location, have a diagnosis, and have a condition that was not diagnosed prior to service.

Rudisill Decision (Supreme Court Decision)

Background: Veterans with multiple periods of qualifying service (and contributed to) the Montgomery GI Bill (MBIB-AD) and also qualified for the Post 9-11 GI bill (Chapter 33) were required to relinquish (waive) their MBIB-AD to use their entitlement to Chapter 33 Benefits. Veterans who used part (or all) of their MBIB-AD were prohibited from using Chapter 33.

Due to the Rudisill Decision, veterans who have qualifying service and entitlement to both MBIB-AD And Chapter 33 can use both benefits.

If a veteran was forced to relinquish (waive) their MBIB-AD benefit may now qualify for up to 48 months of additional GI Bill benefit.

Hello to all my brothers and sisters of the VFW Auxiliary! As I write this, I am thinking about Spring being right around the corner (although Mother Nature can't seem to make up her mind as to what season we are in right now!) and I realize that it is time to think about Auxiliary and District elections! I apologize for the length of this article, but you will see from reading the rest of this article that there are several items of business that need to be taken care of at your Spring meetings!

**Districts:** The Spring District Conventions will be here sooner than you think! Except for one being held in May, these meetings are held in April and will include elections of District officers. Auxiliary Secretaries should be prepared to submit a District Delegate form to the District Secretary prior to your District meeting or your Auxiliary will not have a vote at your District Convention. (See Auxiliaries section below for more information on District Delegates.)

Auxiliaries: Election of Delegates to the District Convention: Auxiliaries must elect one delegate and one alternate for every 15 members in good standing (or fraction thereof) of your Auxiliary at the time of election. If you will be attending your District Convention and want to be considered as a delegate, ask someone to nominate you, or nominate yourself!

Election of Delegates to the Department Convention: Auxiliaries must elect one delegate and one alternate for every 15 members in good standing (or fraction thereof) of your Auxiliary at the time of election. This has to be done no less than thirty (30) calendar days before the Department Convention, so Department has given a deadline of April 30 to have your delegates submitted. If you plan to attend the Department Convention in Pendleton, let your Auxiliary know that you would like to be a delegate so someone can nominate you, or nominate yourself!

Election of Delegates to the National Convention: Per Section 305 of the National Bylaws, delegates and alternates to the National Convention shall be elected at the last regular meeting in April. Auxiliaries must elect one delegate and one alternate for every thirty-five (35) members in good standing (or fraction thereof) of your Auxiliary in good standing on March 31, 2025. If you plan to attend the National Convention in Columbus, Ohio, let your Auxiliary know that you would like to be a delegate.

Election of Auxiliary Officers: Per Section 804B of the 2025 Bylaws, officers shall be nominated and elected at a regular business meeting in April. Are you ready to serve your Auxiliary in some capacity? If you have questions about the duties of any office, refer to your Podium Edition, Section 810 through Section 823. Page 18 through 23 of the yellow pages has even more information regarding the offices of Treasurer and Trustee. You can also find additional information on all offices in the "Building on the Auxiliary Foundation – Guidebook 1." This book in available in MALTA for download and/or printing. And don't be afraid to ask anyone in the Department line if you have questions about serving!

Auxiliary Secretaries: Following election of officers, input the Installation information in MALTA (see Officers/Installation tab in Shortcuts.) Also send a copy of the Installation form to me so I can use the information to create the Roster for 2025-2026. Please send me the long form so I have all the necessary information. If for some reason you are unable to input the information in MALTA yourself, let me know when you send me the Installation form and I will do the input for you.

In closing, thank you for all you do for our veterans, their families and our organization and please feel free to contact me with any questions or concerns. I hope to see you at the Department Convention in Pendleton June 18 through August 22, 2025 and at the National Convention in Columbus, Ohio August 9 through August 13, 2025.

### **LEGISLATIVE CHAIR**

It is time to celebrate two recent wins on the Legislative front:

S.141 Senator Elizabeth Dole 21<sup>st</sup> Century Veterans Health Care Improvement Act, becoming law Jan 2, 2025.

**S.815** Hello Girls Congressional Gold Medal Act of 2024 that passed the senate September 24, 2024. These women struggled for over 60 years to achieve Veteran benefits and recognition as soldiers for their service as telephone operators of the Army Signal Corps in WWI. Finally, they are awarded the Congressional Gold Medal.

Our State Legislative Session began January 21 and will reside for 160 days. Did you know that in even years the session is only 30 days long, but 160 for the odd? Both have the potential to extend for 5 days with a two-thirds vote. To the point: there is significant potential for positive legislative results for our Veterans and their families this year.

Recall that our Oregon VFW Representatives testified at the Capitol on Sept 23, 2024, to support state legislation paralleling the federally introduced H.R. 1139 GUARD VA Benefits Act 2023-2024. On February 3, our leadership sent communications to Oregon's Senate and House Veterans Committees to support the introduction and processing of such a bill and awareness to oppose S.1789/H.R. 1822 PLUS for Veterans Act. Preserving Lawful Utilization of Services also analogously referred to as "Please Let Us Steal". My interpretation of the PLUS Act is that although it poses to support the filing of VA claims for Veterans, and penalize those for directly/indirectly soliciting, contracting for, charging or receiving unauthorized compensations like legalize any agent/attorney to charge fees the GUARD; it does to process the claim. Hence the veteran will pay for the service and have less compensation. The GUARD Act focuses on the utilization of non-profit VSO entities to support and file and penalizing the claims sharks.

Let's take advantage of the 160-day legislative session and get this clear in Oregon, while at the Federal level as well by letters, emails, phone calls, petitions and town halls.

At this time, we are at 96.64% and we need 187 to become 100%+. It's so amazing how many new members have joined us this year. Out of our 36 auxiliaries, 19 of them were 100%+ and that is over half of the auxiliaries in the department. Out of the auxiliaries that haven't made it to 100% most of them have less than 10 members to make their goal. If some of those members are older, a dues angel might be the best thing that could happen for them.

I have another incentive to tempt you with this month. I want to see more auxiliaries attain the goal of 100% so for the next 5 auxiliaries that attain their 100% goal, I will be giving you a monetary prize for your auxiliary for you to use on one of your programs. So, I will be keeping an eye on the numbers and when your auxiliary hits 100% I will send out a check.

I had a little contest in November and December for the auxiliary member that got the most new members for their auxiliary during that time. Well, I don't know how many people read my article, but I only gave out 1 award for this contest and it was to Caitlyn Hacker who got in 2 new members. She was very surprised at her \$50 check.

I am doing something at my auxiliary for the members that haven't paid their dues yet this year. I am going to send them one more letter and let them know that they are now members not in good standing. I am going to inform them that we have been paying their dues for a few years, and we haven't heard from them about wanting to continue. I am going to try to find out from them how old they are since I don't have a birth date on most of them. I will also inform them that we will not be paying their dues anymore and that their membership will lapse at the end of this year. I am hoping to hear from a few of them and find out information about them. Hopefully, they will get back with me and we will be 100% this year.

Any auxiliary or district that has made it to 100% and haven't gotten their bracelets, we will be handing them out at the District meetings and at Convention. I would certainly like to give out a few more of these, they are really pretty, and they were a different idea. Hope to see you at the district meetings.


#### THE VFW HONORS WOMEN'S HISTORY MONTH!

## **Recognize Vietnam War Veterans on March 29**

March 29 is National Vietnam War Veterans Day. It marks the day in 1973 when all U.S. ground troops departed Vietnam. Only U.S. embassy personnel and support staff remained in South Vietnam until the fall of Saigon on April 30, 1975. This day is set aside for Americans to recognize every Vietnam War veteran to include those who are still unaccounted for. From February 1961 to May 1975, more than 3.4 million Americans served in support of US military operations in Vietnam and Southeast Asia. More than 58,000 gave their lives, and nearly 1,580 service men remain unaccounted for, according to the Defense POW/MIA Accounting Agency.

#### Commander's Leadership Spring Retreat



A service for Helen was held in Molalla on February 15, 2025.












### VFW POST 1324 IN OREGON CITY MARKS 100 YEARS OF SERVICE TO VETERANS AND THEIR COMMUNITY!

100 YEARS! That is how long the VFW has resided in Oregon City. On February 17, 1925, our Post was chartered. In 2025 we marked 100 years of continuous service to Veterans and our community. The occasion was marked with an unveiling of a new bronze plaque along with the restoration of the first two plaques from 1949 when our building was opened.

The plaques were unveiled by two veterans, WWII Veteran Art Kimball & GWOT Veteran KC Johnson. Larry Kirk and Scout Troop 220 member Uriah Avery laid a wreath at the base of the plaques after the reveal. Larry Kirk and his twin Gary, who could not attend, were only 8 years old when they broke ground in 1948 for what was to become the Clackamas County Veterans Memorial Building, home of Three Rivers VFW Post 1324. It was a wonderful presentation with attendees from the Oregon City High School JROTC, the Mayor of Oregon City, and many other local community leaders. State Senator Mark Meek (@senatormarkmeek) sang a beautiful rendition of the National Anthem followed by the Post 1324 Rifle Salute.

VFW National Commander, Alfred "Al" Lipphardt awarded Post 1324 the CENTURY Award, which was presented by Department of Oregon Commander, Andrea Summerlin at a ceremony held at the Post on February 16, 2025.
